<p><b>6 Corporate Tenancies</b> Any tenancy where to my knowledge the landlord is the Council and the tenant is a body in which I (or a Relevant Person) has a beneficial interest.</p>		
<p><b>7 Securities</b> The name of any person or body in which I (or a Relevant Person) has a beneficial interest in securities of that body where:</p> <ul style="list-style-type: none"> <li>a) That body to my knowledge has a place of business or land in the Parish; and</li> <li>b) Either: <ul style="list-style-type: none"> <li>i. The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</li> <li>ii. 2. Provide information that is materially false or misleading; or
3. Fail to provide written notification to the Council's Monitoring Officer of any change in my interests contained in this notice within 28 days of my becoming aware of such change of circumstances.
